## Palestinian held for stabbing soldier in Tel Aviv

**Jerusalem:** Israeli police say a 17-year-old Palestinian stabbed a soldier in central Tel Aviv, lightly wounding him before being arrested after a short chase.

Video footage broadcast by Israeli TV shows the Palestinian holding what appears to be a knife and yelling at officers who arrested him on the stairwell of an apartment building in Tel Aviv.

Monday's assault appeared to be the latest in a series of Palestinian attacks against Israeli civilians and security personnel over the last eight months. The stabbings, shootings and vehicular assaults have killed 28 Israelis and two Americans. About 200 Palestinians were killed during that time, mostly attackers, Israel says. The assaults have been less frequent in recent weeks. **AP**

# Post-conflict reconciliation with Tamils a priority: Sirisena

**Colombo:** Sri Lankan President Maithripala Sirisena on Tuesday said post-conflict reconciliation with minority Tamils was his Government's top priority while being committed to uphold human rights and democracy. Addressing the State functionaries commemorating the seven-year anniversary of the end of the three-decade long brutal conflict between the LTTE and the Government, he said: "The main responsibility entrusted on my Government was to achieve post-conflict reconciliation. We will achieve that while paying tribute to the heroic

forces who ended the war seven years ago, Sirisena said. "My Government will uphold human rights and democracy," he said. Sirisena said his Government had accorded utmost priority to the welfare of soldiers despite criticism from his political opponents. The ceremony marked the official commemoration of the end to the LTTE's 30 year separatist campaign. Sirisena's Government in sharp contrast to the Government of the predecessor Mahinda Rajapaksa has taken many a conciliatory steps towards the Tamil minority. **PTI**
