Woman slits daughter's throat

Six-year-old girl was killed by her mother after the minor had seen her with her lover and threatened to tell about it to her father

New Delhi: In a horrific incident, a woman and her paramour allegedly slit the throat of her minor daughter after she found out about their affair and threatened to tell her father in East Delhi's Ghazipur area, police said on Thursday.

The six-year-old girl was found dead, her throat slit at the terrace of her neighbour's house in East Delhi's Ghazipur Dairy farm in the late hours of Wednesday night. A senior

police official of the East district said they have detained the minor girl's mother and her paramour. "As per the preliminary investigation, woman had confessed that her daughter had seen her with her lover a couple of days back. She had threatened to tell her father about her mother's affair. Fearing that she will be exposed, the mother hatched plan to kill her daughter," said the officer.

On Wednesday night, the

minor girl had reportedly gone with her two siblings to watch TV at her neighbour's house at 9 pm. "When the girl went out and did not return for one-and-a-half hours, her family started searching for her everywhere. It was later that they found her bleeding profusely. The victim, a Class-I student in a Government school, was found with her throat slit on the terrace of the building.

The senior officer added, "During the investigation, all the eight families residing in the building were questioned. When the mother of the victim was questioned, she changed her statements, making cops suspicious. During sustained ques-

tioning, cops found that the girl's mother was having an extra-marital affair."

Initially, the Ghazipur police team had suspected witchcraft to be one of the motives behind the murder. One of the siblings, a two-and-a-half-year old boy had allegedly told police that his sister was called out of the house by a shadow.

Police said they have sent the body for autopsy. So far, police has denied that the minor girl was sexually assaulted but are waiting for the post-mortem reports and accordingly will add IPC Sections. Police had registered a case under Section 302 of the IPC at the Ghazipur police station. **SR**

Man dupes selling fake

A 32-year-old man has been arrested by the Cyber Cell of Delhi Police's Crime Branch for allegedly duping roughly 15,000 people to the tune of ₹50 crore by selling fake digital currency with the name of Kashhcoin.

Joint Commissioner of Police (Crime) Alok Kumar said, "The arrested accused, Narender, alias Sonu Dahiya, is a resident of Sonipat in Haryana. Police said that with Narender's arrest, role of seven to eight more persons is under radar of the police team

A senior investigator said the accused disclosed that he used to work as a property dealer but six years ago, in 2011, owing to financial losses, Narender started working as a multi-level marketing officer, along with several people. They first created a website and started organising seminars to publicise about the cryptocurrency among people in cities like Mumbai, Delhi, Nagpur, Gujarat, Chandigarh, and Raipur. Unaffiliated Gurugram schools to face music

The Deputy Commissioner (DC) of Gurugram has instructed educational officials to identify the schools running without mandatory Government permission. The DC has issued orders that such schools must take permission from the education department before March 2018 to avoid any action against them. The DC also has also appealed to the parents not to admit their children to such schools.

"It has come to my notice that hundreds of private schools are running in the district without prior Government permission. We have formed a team of educational officials which will guide the parents to admit their children in affiliated schools who are running as per the Government rules," said Vinay Pratap Singh the DC.

He said that many private schools are found running

mandatory as per the Government norms.

"District Education Officers and District Elementary Education Officers have been directed to ensure that any private school should not be opened without necessary permissions and submitted a list of those schools that are not following mandatory Government permission before March 2018. So that a strict action will be initiated against them," the DC said.

As per the norms, secondary schools should have five-acres of land in rural areas for their operation while in the city it should be two-acres. Besides, around 20 to 24 classrooms, playground and teachers should have B.Ed. (Bachelor of Education) degree.

Talking about the quality education in the Government schools, the DC said "the government schools initiated measures to improve the quality of education on par of corporate
